

# BETWS COMMUNITY COUNCIL

## **Title: 2005 10 October Minutes**

The monthly meeting of the Council was held at Capel Newydd Vestry, Betws on Wednesday the 12th October 2005 at 7.00 pm.

### 1. TO READ AND CONSIDER THE MINUTES OF THE MEETING HELD ON THE 14th SEPTEMBER 2005.

The following amendments were made:-

2.2 Councillor Carwyn James said that the issue in Parc Penrhiw is unacceptable.

8.1 Removal of the goldfish pond, pump house, commemorative garden in commemoration, of the Mining Community of Betws.

8.2 Councillor Loreen Lewis was also present at the meeting.

The minutes of the monthly meeting held on the 14th September 2005 were amended and signed.

### 2. MATTERS ARISING.

2.1 Walkway to Betws CP School from Colonel Road, Betws.

Councillor June Gunter asked for an update in relation to the above. Councillor Peter Cowell reported that the walkway to Betws CP School from Colonel Road has been cleared.

Councillor Peter Cowell also informed the Councillors that County Councillor John D Evans has written to Carmarthenshire County Council to enquire whether the County Council can make this a hard surface footpath. The above point was NOTED.

2.2 Betws Park.

The Clerk read an email received from Tanja James concerning funding for Parks - Trim Trail. Councillor Annette Price confirmed that she would try and obtain further information from Tanja James.

The above point was NOTED.

2.3 Betws In Bloom.

Councillor Anne Sizmur stated that she has paid out £37.60 for the engraving of the Betws In Bloom trophy cups. All Councillors agreed to reimburse Councillor Anne Sizmur.

RESOLVED: to pay Councillor Anne Sizmur the sum of £37.60.

### 3. CORRESPONDENCE.

3.1 The Stile Company.

The Clerk informed the Councillors that she has received a request from the Stile Company asking for permission from Betws Community Council to place an oak seat or bench on the Common Land behind Full moon. The Councillors had no objections, but they did suggest that the Stile Company should also consult with the Commoners.

RESOLVED: the Clerk to notify the Stile Company that the Councillors had no objections.

### 3.2 Amman Group of Local Councils.

The Clerk read the letter she has received from the Amman Group of Local Councils asking if Betws Community Council can put a formal proposal before its Councillors stating that it wishes to join in extending the invite to the National Eisteddfod to the Amman Valley in 2012. Councillor Anne Sizmur read a proposal to the Councillors. This was discussed and all Councillors were in favour of supporting this.

RESOLVED: that the Clerk sends the proposal to the Amman Group of Local Councils.

### 3.3 Wind Turbine Planning Application.

Councillor Graham Vaughan questioned the previous decision made by Betws Community Council concerning the Wind Turbine Planning Application. The Clerk informed the Councillors that she has received correspondence in relation to the Wind Turbine Planning Application. Councillor Peter Cowell said that the decision put forward by Betws Community Council couldn't be overturned within six months. It was decided not to discuss the matter further.

### 6. DYFED POWYS POLICE REPORT.

PC Geoff Harries attended the meeting on behalf of Dyfed Powys Police. He reported that the following crimes were committed in the Betws area during September:-

2 assaults, 1 possession of ecstasy, 2 possessions of cannabis on Betws Mountain, 1 theft of mobile phone and 1 theft of vehicle. To date they have not been detected.

255 youngsters attended the Blue Light Disco that was held in September. The next disco is on the 20th of October. Councillor June Gunter commended the Police on the tremendous job they are doing with regards to the Blue Light Discos.

County Councillor John D Evans reported that he has received a complaint in relation to

vehicles speeding on Maesquarre Road and Betws Mountain between the hours of 8-9 am and 5-6 pm. PC Harries stated that he would pass this onto PC Kevin Jones.

#### 7. COUNTY COUNCILLOR REPORT.

County Councillor John D Evans updated the Councillors with regards to the Betws Mine Site.

##### 8.1 Footpaths.

Councillor Anne Sizmur informed the Councillors that she has organised the Crime Evening. The above point was NOTED.

##### 9.3 Betws CP School.

Councillor June Gunter asked whether the Clerk has received a response from the Headteacher of Setws CP School with regards to her attending the monthly meetings of Setws Community Council to update the Councillors on what's happening in Setws CP School. The Clerk apologised as she thought Councillor Anne Sizmur was going to speak to the Headteacher.

RESOLVED: that the Clerk writes to invite the Headteacher of Setws CP School, to the next Meeting of Setws Community Council.

##### 9.4 Betws Community Council Surgeries.

Councillor Anne Sizmur asked the Councillors whether they wanted to continue with the Council Surgeries. The above was discussed and resolved that Councillors Arnallt James and Audrey Jones would attend the next months Council Surgery starting at 6.30 pm and that Councillors Arnallt James and Anne Sizmur would attend the surgery in December.

##### 9.5 Meeting of the 4th October 2005.

Councillor Loreen Lewis informed the Councillors that the Clerk has received a letter of complaint, which concerns one of the Councillors from Setws Community Council. The clerk has referred the letter onto One Voice Wales and is currently waiting for legal advice. The Councillors will be notified of the advice received in due course.
