### BETWS COMMUNITY COUNCIL

The monthly meeting of Betws Community Council was held at Capel Newydd Vestry, Betws on Wednesday the 9th November 2011 at 7.00 pm.

### 2. DECLARATION BY MEMBERS OF PECUNIARY AND NON PECUNIARY INTERESTS

### 3. TO CONFIRM AND SIGN THE MINUTES OF THE MEETING HELD ON 12th OCTOBER 2011

Item 6 – Page 2. Add “and religious sites” after the word “archaeological.”

Councillor Anne Sizmur proposed and Councillor Loreen Lewis seconded, that the minutes of the monthly meeting held on the 12th October 2011 be confirmed and signed by the Chairperson.

### 4. DYFED POWYS POLICE

.PC Kevin Jones was not present.

### 5. COUNTY COUNCILLORS REPORT

County Councillor Audrey Jones gave members a leaflet listing matters which are ongoing, including the steps in Betws Park, the archway, resurfacing of Pentwyn Road, and Maesquarre Road bridge.

Councillor Annette Price asked when work on the steps will commence ? County Councillor Jones stated the work will start soon, and will cost approximately £1500.

County Councillor Jones also brought to the councils attention, a complaint received from certain residents of Parc Bwtrimawr, regarding the bright lights and noise coming from the Tesco stores opposite their properties. County Councillor Jones explained that she had already met the manager at Tesco, and she was also due to meet officers from the County's Public Protection Department.

RESOLVED the Clerk writes a letter to the County Councillor, expressing our support for her efforts on this matter.

Alderman Arnallt James informed the meeting that two mature oak trees had been felled in Maesquarre Road. Following a short discussion the Clerk was asked to contact the Tree Officer for his views on this matter together with other trees in the village.

## 6. MATTERS ARISING

### 6.1 RELIGIOUS SITES ON MYNYDD Y BETWS

Councillor Cath Smith explained that her mother in law knew of many sites on the mountain, and that there were many reference books available on the subject.

There followed a short general discussion about the turbines, where a question as to what powers the turbines was asked.

RESOLVED the questions are asked when we next meet Cambrian Renewable Energy.

### 6.2 ARCHWAY IN BETWS PARK

County Councillor Audrey Jones explained in her report that the roof of the Archway will be repaired at the end of the financial year if the resources are available.

The above point was NOTED.

### 6.3 SECTION 106 FUNDS – MAESQUARRE PARK

The County Councillor was now involved with this dispute, and there was nothing to report at this time.

RESOLVED the Clerk pursues the matter with the County Councillor.

### 6.4 QUAY STREET RAILWAY CROSSING

The Clerk reported that he had received no replies from both Network Rail and the County Council. Councillor Anne Sizmur also stated that Trevor Workman had also declined the invitation to meet the Amman Valley Group of Councils.

RESOLVED the Clerk writes to Chris Burns, to complain about the County's lack of response, and also to try and find out if there was a complaints line for Network Rail.

### 6.5 PARKING OUTSIDE MAESQUARRE PLAYGROUND

The Clerk stated Mr John McEvoy had suggested that erecting bollards would alleviate the problem of pavement parking at this location. Members did not agree with this suggestion, stating that parents would then park fully on the road, which would then cause more congestion. Following a short discussion it was suggested that "zig-zag lines" on the road might be a solution.

RESOLVED the Clerk writes to Mr McEvoy with this proposal.

### 6.6 FOOTPATHS

Alderman Arnallt James asked if a site meeting could be arranged with Mathew Palmer the footpaths officer, to discuss various issues.

RESOLVED the Clerk asks Mathew Palmer to meet Alderman James.

### 6.7 POTHOLES NEAR SCOTCH PINE

The Clerk reported that the potholes had been dealt with. However Councillors stated that there were still a few more needing attention, and also there was a hole outside Garthowen, Maesquarre Road.

RESOLVED the Clerk informs the Highways Department.

#### 6.8 AIRSHAFT AT MAESQUARRE HALL

Councillor Anne Sizmur informed the meeting that inspectors from the Coal Authority had visited many airshafts in the area, and a letter giving their findings will be sent out soon.

Land is not on proposed UDP, but is on the current one which is due to be replaced.

Problems with sewerage, drainage and surface water.

Two public footpaths will be affected

Increase in traffic on a bend and a brow of a hill.  
Permission already granted to development opposite which will double highway concerns.  
Poor visual appearance.  
Underground mine corridors are present.

Following discussion it was agreed to REFUSE the application.

RESOLVED the Clerk informs the Planning Department.
