Betws Community Council- Auditor General for Wales' Audit Certificate and report

The Auditor General for Wales issued Betws Community Council an unqualified audit report.

However, during our review we identified some other matters that we wish to draw to the Council's attention which do not affect our audit opinion but should be addressed by the Council.

Terms of reference

The Council had not adopted terms of reference for each of its committees and sub-committees during 2018/19. The Council had thus correctly answered 'No' on the Annual Governance Statement (Part 2), Assertion 3, and has now confirmed that it is in the process of adopting the terms of reference.

In future years, the Council should ensure terms of reference are adopted as soon as a Committee is established.
